The Visa Applicant is responsible for ensuring connection to a mobile network capable of receiving the SMS Services. The Visa Applicant understands that if The Visa Applicant 's mobile phone is switched off, disconnected for any reasons or is out of coverage for a period of 24 hours or more, The Visa Applicant's mobile network provider may delete any SMS messages to be received by The Visa
- 2. **OFFICIAL REGISTRATION IS RECOMMENDED** for **ALL Americans** traveling abroad for business or pleasure, or residing abroad, irrespectively of the length of travel.

It is best to register **BEFORE** the start of the trip.

To register, you are required to fill-out short US Embassy Registartion Request Form with your basic contact and travel information.

- Original, signed United States passport with at least 6 months of remaining validity.
- Two color passport-type photographs against white background. (Photo facility is available at all Visa Centers for \$10)
- Filled-out and signed Egypt visa application form.
- Persons with dual citizenship, one of which is US, must apply with their US passports only.
   Applicants with other than US passports must provide the copy of the document confirming
   their current resident status in USA (photocopy of green card or valid U.S. Visa and
   photocopy of round-trip ticket or itinerary. Student Visa Holders PLEASE
   ALSO PROVIDE a Registration Letter from school.)

# Egypt Business Visa Requirements (additionally to the requirements above)

• Business Letter. A business letter from the sending company in the US. The letter should be printed on the company letterhead stationery, addressed to "The Consulate of Egypt, Visa Section", and signed by a senior manager (an equivalent to Vice-President or above). The business letter must adhere to the following guidelines: Briefly introduce the applicant (please specify employment status/position held in the company by applicant). State the nature of the business to be conducted (ie. business meetings, contract negotiations, etc.) and the names and addresses of companies to be contacted in Egypt. Specify the type and desired validity of the visa (ie. a one year multiple entry business visa). Guarantee of sufficient funds for travel.

REQUIREMENTS (Incomplete requirements will delay the visa process):

- 1. Duly filled and signed Visa Application Form
- Two (2) passport size photos (size 2x2), with WHITE background. Person must be facing directly at the camera showing both ears.
- 3. PASSPORT (valid for 6 months from date of entry to Egypt)
- 4. FEE: \$ 15 per passport for US Citizen in CASH, USPS Money Order or cashier's check payable to Egyptian Consulate. Other checks or credit cards are not accepted For other nationalities, please contact the Consulate for fees and other requirements.
- For Non-American, photocopy of greencard.
- 6. For Business Visa: a letter from the company stating purpose of the trip and financial guarantee of the company.

#### APPLICANTS BY MAIL:

Send the above requirements (we need the original passport) with a self-addressed, prepaid envelope for the return of passport/s. If sending via USPS- e.g. Express Mail, Priority Mail with confirmation, please send proper postage. Do not send metered stamps. Couriers e.g. Airborne, DHL, Fedex with company accounts are acceptable. WE DO NOT ACCEPT CREDIT CARD ACCOUNT NUMBERS.

The Consulate is not responsible for the return of any document/s or passport/s by mail or any loss, delay or damage that may occur in the mailing of document/s or passport/s.

#### IMPORTANT NOTICE:

- CUSTOMS DECLARATION: There is no limit on the amount of currency which the visitors may bring to Egypt, however, they must declare the currency and amount on Form D upon arrival and departure with bank receipts. If you are earrying Egyptian Currency, it should not exceed 5,000 L.E.
- HEALTH CERTIFICATE: Required only if traveler is coming from an infected area.
- VALIDITY: Tourist visas are valid for 6 months from date of issue. Business visas are valid for 6 months from date of issue. WORK: Holders of tourist visas are not allowed to work in Egypt.
- PROCESSING TIME: 5 business days. By mail is 7-10 working days, excluding mailing time
- Incomplete requirements will delay the visa process.
